2. Inspection by the DPBR will be held on Friday, November 1st, any vendors without FL. License will be asked to pay \$91.00 in money order form.

3. Only products with prior approval will be allowed for sale at festival. Any changes or additions MUST be approved in advance by the committee. No Exceptions allowed!!.

4. We will mail you notification or Phone you of acceptance or denial. Acceptance is not implied upon application being received. You will be contacted by mail or by phone after application is received.

5. BOOTH APPEARANCE IS EXTREMELY IMPORTANT!! Exhibitor must furnish their OWN canopy, tables, chairs, trash receptacles, etc. The more attractive

your booth, the better you will sell. BE PREPARED FOR RAIN OR SHINE, as the show will go on! <u>\*\*Must make sure all</u> booths are secured down. Security is provided for the park, however, the Festival board is not responsible for missing or broken items.\*\*

6. Welcome packets containing gate passes and parking instructions will be given upon check in by the food committee. 7. Designated areas for RV parking will be available in limited supply (on a first received application / first served basis). RV's must be self-contained as far as

p.m. Some set-up may go on wed evening if director and food vendor agree .Gates open 10 a.m. and close at 11 p.m. on Friday and Saturday. \*\*No Moving Traffic will allowed in park after 8:00am on the 4<sup>th</sup> & 5<sup>th</sup> due to strict insurance liability.\*\*
9. Cancellation deadline is Tuesday Oct.15th by 5:00pm. Any cancelations after this date will be non-refundable

The Florida Seafood Festival Vendor Committee reserves the right to: review and compare items sold with items listed on this Application has removed for sale any items not approved in advance or found to be re-sale items. Vendors not complying with this rule will be subject to removal from the Festival without refund of their fees.

ANY violation of this rules can cause immediate closer of for profit food booth with non-returnable entry fee.
