*Only products with prior approval will be allowed for sale at festival. Any changes or additions MUST be approved in advance by the Committee. No Exceptions allowed!! Items for sale by Arts & Crafts Vendors shall be handmade. No Buy/Resale. No exceptions.

* We will Email you notification of acceptance or denial within 15 days of receipt of the application. Acceptance will be dependent upon receipt of your application, pictures and payment. No further contact will be necessary.

* BOOTH APPEARANCE IS EXTREMELY IMPORTANT!! Exhibitor must furnish their OWN canopy, tables, chairs, trash receptacles, etc. The more attractive your booth, the better you will sell. Be prepared for rain or shine, as the show will go on! Booth must be well secured in the ground in case of bad weather. **Security for the park will be provided, however, The Festival board will not be liable for any property missing or damaged.**

*Welcome packets containing booth assignments, tax information, gate passes and parking will be given upon check in at the front gate in Battery Park.

* Designated areas for RV parking will be available in limited supply (on a first received application / first served basis). RV's must be self-contained as far as POWER/WATER and SEWAGE are concerned.

* Setup will be on Thursday, November 3rd from 9:00 - 5 p.m. Gates open 10 a.m. and close at 11 p.m. on Friday and Saturday.

* Booth fee is non-refundable. **All booths must be set up by 5:00 pm on the 5th. There will absolutely NO moving vehicle traffic allowed in park after closing of park setup at 5:00 pm due to strict liability insurance.**

* The Florida Seafood Festival Vendor Committee reserves the right to: review and compare items sold with items listed on this application, have removed for sale any items not approved in advance or found to be re-sale items. Vendors not complying with this rule will be subject to removal from the Festival without refund of their fees.

* Absolutely NO projectiles, silly string, fart bombs, fireworks/firecrackers or rubber band operated toys shall not be sold by any vendor!!

* No Vendor may break down before Saturday November 5th at 11:59 PM EST.

* No Vendors may sell outside of festival grounds.
